

Why should I participate?

Advantages for the donor:

- Convenience – your offering is given automatically each month
- Easier to keep track of your donations
- Continued support of St. Martin's when you are away
- No more cheque writing or finding the right amount of cash

Advantages for St. Martin's:

- Regular, dependable flow of donations to support the work of the parish
- Reduction of paperwork and bookkeeping
- Reduction in late payment charges resulting from irregular cash flow

How does PAR work?

- When you participate in PAR, your bank account is debited on the 20th of each month. This amount is then credited to the parish account. Your bank statement will show: *PAR St. Martin*
- The program is administered on our behalf by The United Church of Canada. Receipts are issued by St. Martin's.

How do I enroll?

- Complete the Authorization Form on the reverse side. This authorizes the United Church to withdraw the specified amount
- Complete the Distribution Instructions at right to identify how you want your monthly donations allocated
- Return the entire brochure, together with a void cheque, to the attention of the PAR Contact
- If you do not have cheques, your bank branch can provide the information required
- Changes in the amount of your donation do not require a void cheque, unless your bank account has changed

How will PAR change how I support St. Martin's?

- Normal offering envelopes will be issued to all PAR participants. The envelope number will be used to track donations for tax receipt purposes. Additional givings for special projects or festivals such as Easter or Thanksgiving should be made using these envelopes
- If you would feel uncomfortable about not placing anything on the offering plate, please use one of your envelopes, leave it empty, write 'PAR' on the front and place it on the plate. (No amount or details needed)
- You may cancel or change your donations at any time by contacting the PAR Contact.

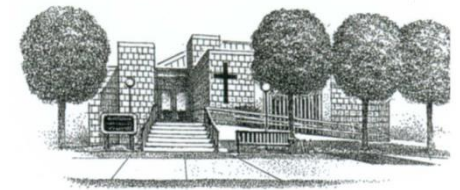

Pre-Authorized Remittance is a
simple way to make your church
donations

- *I may change the amount of my contribution at any time subject to providing notice of 15 days*
- *I may revoke my authorization at any time subject to providing notice of 15 days at which time I will submit a Cancellation Form, available from the PAR Contact, or by contacting my financial institution or visiting www.cdnpay.ca*
- *I have certain recourse rights if any debit does not comply with this agreement. For example I have the right to receive reimbursement for any debit that is not authorized or is not consistent with this PAR agreement. To obtain more information on my recourse rights, I may contact my financial institution or visit www.cdnpay.ca*
- *I waive my right to receive pre-notification of the amount of the Pre-Authorized Remittance (PAR) and agree that I do not require advance notice of the amount of PAR before the debit is processed.*

To begin PAR or change banking details, an unsigned cheque, marked VOID, must accompany this authorization. If you do not have cheques, the required information may be obtained from your bank branch. A cheque is not required for changes in the amount of the donation.
